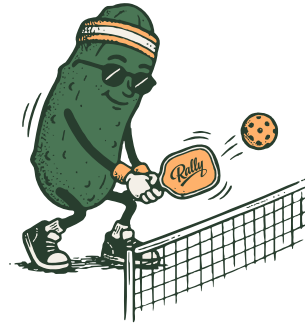


COURT BOOKING & PROGRAMMING GUIDELINES



About Rally

The Rally pickleball courts are a vibrant, community-focused amenity within Royal Bay, designed to support recreation, wellness, and social connection. While the courts remain free and publicly accessible for casual recreational play, PATH Developments recognizes the growing interest in organized programming and community events. To ensure fair access and a positive experience for all users, organized activities require advance approval.

ELIGIBLE PROGRAMMING

Examples of organized programming include:

- Lessons & Instruction
- Clinics
- League Play
- Tournaments
- Youth Camps
- Community Events
- Charity Events & Fundraisers
- Corporate Events

All organized programming must be approved in advance.

OPERATING HOURS

Spring / Summer

Monday–Friday: 9:00 AM – 8:00 PM

Saturday–Sunday: 9:00 AM – 7:00 PM

Fall / Winter

Hours are subject to seasonal daylight and operational adjustments.

Programming outside approved operating hours is not permitted.

COURT AVAILABILITY

Approval is subject to:

- Existing bookings
- Community events
- Site maintenance
- Operational requirements
- Seasonal programming initiatives

PATH Developments reserves the right to modify court availability as required.

BOOKING FEES

Approved programming will be subject to applicable fees.

Current booking rates:

- Hourly Court Rental: \$25/hour per court
- Half-Day Rental: \$100 per court
- Full-Day Rental: \$200 per court
- Tournament/Event (All Courts, Half Day): \$375
- Tournament/Event (All Courts, Full Day): \$750

Additional fees may apply depending on event requirements.





COURT BOOKING & PROGRAMMING GUIDELINES

INSURANCE REQUIREMENTS

Approved events will be required to provide:

- Commercial General Liability Insurance
- Minimum \$5,000,000 coverage

Additional insurance requirements will be provided upon approval.

ORGANIZER RESPONSIBILITIES

Approved organizers are responsible for:

- Participant supervision
- First aid readiness
- Safe equipment usage
- Compliance with posted site rules
- Maintaining site cleanliness
- Respecting neighbouring residents and businesses
- Adhering to approved operating hours

Failure to comply may result in suspension of booking privileges or future approvals.

BEFORE YOU APPLY

Please note that court availability may be limited during community events, maintenance periods, seasonal programming, and other operational requirements.

HOW TO APPLY

3. Submit your application to rally@royalbay.ca.

Submission of an application does not guarantee approval.

Approval is based on availability, operational considerations, and the overall community impact of the proposed programming.
